Appendix E of the Final Environmental Impact Statement (FEIS) for the Atlantic Coast Pipeline (ACP) and Supply Header Project (SHP) (collectively, the Projects) identifies Access Road 07-001.AR1-AR8 on the George Washington National Forest as a proposed long term use access road. However, this access road was proposed for temporary use in Table E-1 in the response to Question 6 of the FERC’s Environmental Information Request dated April 11, 2017 (response filed on May 8, 2017; FERC Accession Number 20170508-5071) and is still proposed for temporary use during construction of the ACP.

2.0 ENVIRONMENTAL AND CULTURAL RESOURCES**2.1 Biological Survey Reports**

Atlantic Coast Pipeline, LLC (Atlantic) and Dominion Energy Transmission, Inc. (Dominion Energy) are conducting surveys for various rare, threatened, and endangered species and/or habitat for these species as recommended by the U.S. Forest Service, U.S. Fish and Wildlife Service (USFWS), and/or State/Commonwealth wildlife management agencies. With this filing, Atlantic and Dominion Energy are providing the following biological survey reports and plans for the Projects:

- Bat Survey Report for the ACP in West Virginia;
- Bat Survey Report for the ACP in Virginia;
- Plant Survey Report for the ACP in Virginia;
- Plant Survey Report for the SHP in West Virginia; and
- Revised Protected Snake Conservation Plan for the ACP and SHP in West Virginia.

Atlantic and Dominion Energy sent copies of these documents to the USFWS and State/Commonwealth wildlife agencies, as appropriate, for review and comment. Copies of the bat and plant survey reports and transmittal letters to the agencies are provided in Appendix A. Because these reports contain location information for sensitive species, they are marked “Contains Privileged Information – Do Not Release”. Copies of the protected snake conservation plan and associated agency transmittal letter are provided in Appendix B. Atlantic and Dominion Energy will file comments from the USFWS and State/Commonwealth agencies on each report or plan, as appropriate and applicable, when available.

2.2 Cultural Resources Survey Report

In its response to Question 41 of FERC's Environmental Information Request dated October 26, 2016 (response filed on November 9, 2016; FERC Accession Number 20161109-5138), Atlantic committed to completing cultural resources field surveys on the Nelson County Creekside, LLC property in Nelson County, Virginia once permission to survey this parcel was obtained. Cultural resources surveys along the proposed pipeline route are now complete on this tract. No artifacts, features, or structures associated with prehistoric or historic human activity were identified within the survey corridor on the parcel. These results were included in the report titled *Phase I Archaeological Survey of the Atlantic Coast Pipeline Project, Virginia Addendum Report 4*, which was filed on February 24, 2017 (FERC Accession Number 20170224-5150). The Virginia Department of Historic Resources (VDHR) concurred with the findings of this report in a letter to Atlantic dated June 9, 2017, a copy of which was filed on July 28, 2017 (FERC Accession Number 20170728-5118). Additionally, desktop review and field reconnaissance indicate that no historic structures occur within the visual area of potential effects (APE) for the ACP on the Nelson County Creekside, LLC parcel. The visual APE and survey results for historic structures are depicted in the map set provided as Appendix A to the report titled *Phase I Historic Architectural Survey of the Atlantic Coast Pipeline Project: Virginia Assessment of Effects Report*, which was filed on July 28, 2017 (FERC Accession Number 20170728-5118).¹ This report is currently under review by the VDHR.

2.3 Updates to Unanticipated Discovery Plans

Staff Recommendation 66.b.iii of the FEIS for the Projects directed Atlantic and Dominion Energy to file "revised *Unanticipated Discovery Plans* that include tribal contact information for those tribes that request notification following post-review discovery of archaeological sites, including human remains, during project activities". Updates to Atlantic's and Dominion Energy's state-specific unanticipated discoveries plans for the ACP (West Virginia, Virginia, and North Carolina) and SHP (West Virginia and Pennsylvania) are provided in Appendix C. Revisions to the plans include: the addition of the Pamunkey Tribe and Virginia state-recognized tribes as parties to be notified in the event of a post-review discovery in Virginia (ACP Virginia plan); the addition of North Carolina state-recognized tribes as parties to be notified in the event of a post-review discovery in North Carolina (ACP North Carolina plan); and updated contact information for Atlantic or Dominion Energy, as appropriate, and local law enforcement, as warranted (all plans).

3.0 AGENCY CORRESPONDENCE

Atlantic submitted summaries of agency contacts and copies of select correspondence with agencies in Appendices 1H and 1I of Resource Report 1, which were filed with the FERC Application on September 18, 2015 (FERC Accession Number 20150918-5212). Updated summaries of agency contacts and copies of correspondence were also provided with supplemental filings or data responses on October 30, November 13, and December 15, 2015;
