Staff Recommendation 25 of the Final Environmental Impact Statement (FEIS) for the Atlantic Coast Pipeline (ACP) and Supply Header Project (SHP) (collectively, the Projects) directed Atlantic Coast Pipeline, LLC (Atlantic) and Dominion Energy Transmission, Inc. (DETI) to file a *Plan for Discovery of Unanticipated Paleontological Resources*. Atlantic's and DETI's plan, which is provided as Appendix A, identifies procedures to be implemented in the event that significant paleontological resources are found during construction, including notification of FERC and the appropriate authorities in each State/Commonwealth crossed by the Projects.

1.2 Staff Recommendation 59

Staff Recommendation 59 of the FEIS for the Projects directed Atlantic to file an updated *Contaminated Media Plan* that considers recommendations from the Virginia Department of Environmental Quality (VDEQ) as provided in a letter to FERC dated April 6, 2017 (FERC Accession Number 20170406-5489). An updated version of the plan in consideration of the VDEQ comments is provided in Appendix B. Atlantic sent the updated plan to the VDEQ for review on August 23, 2017. A copy of Atlantic's transmittal letter to the VDEQ is included in Appendix B with the updated plan. Atlantic will file comments from the VDEQ on the updated plan, if any, when available.
