1.0 RESPONSES TO STAFF RECOMMENDATIONS

1.1 STAFF RECOMMENDATION 52

Staff Recommendation 52 of the Final Environmental Impact Statement for the Projects directed Atlantic to file a site-specific *Organic Farm Protection Plan* for the certified organic farms affected by ACP, including (but not limited to) the milk and corn farm crossed between AP-1 mileposts (MPs) 141.8 and 142.4; the certified organic hog farm crossed between AP-2 MPs 118.8 and 118.9; and any additional certified organic farms not previously identified prior to construction. Site-specific *Organic Farm Protection Plans* for the certified organic farms crossed by the ACP between AP-1 MPs 141.8 and 142.4 and AP-2 MPs 118.8 and 118.9 are provided in Appendix A. No other certified organic farms are crossed by the Projects.

2.0 ENVIRONMENTAL AND CULTURAL RESOURCES

2.1 BIOLOGICAL SURVEY REPORTS

Atlantic Coast Pipeline, LLC (Atlantic) and Dominion Energy Transmission, Inc. (Dominion Energy) are conducting surveys for various rare, threatened, and endangered species and/or habitat for these species as recommended by the U.S. Forest Service, U.S. Fish and Wildlife Service (USFWS), and/or State/Commonwealth wildlife management agencies. With this filing, Atlantic is providing the following biological survey reports for the Atlantic Coast Pipeline:

- Final Locally Rare Species Report for the George Washington National Forest;
- Final Management Indicator Species Report for the Monongahela and George Washington National Forests; and
- Rusty Patched Bumble Bee Habitat Assessment.

Atlantic and Dominion Energy sent copies of these documents to the USFWS and U.S. Forest Service, as appropriate, for review and comment. Copies of the reports and transmittal letters to the agencies are provided in Appendix B. Because these reports contain location information for sensitive species, they are marked "Contains Privileged Information – Do Not Release". Atlantic will file comments from the USFWS and U.S. Forest Service on each report, as appropriate and applicable, when available.

3.0 AGENCY CORRESPONDENCE

Atlantic submitted summaries of agency contacts and copies of select correspondence with agencies in Appendices 1H and 1I of Resource Report 1, which were filed with the FERC Application on September 18, 2015 (FERC Accession Number 20150918-5212).
