The Nelson County Administration sent several letters to FERC which were filed to the docket, including letters regarding stakeholder engagement, alternatives, and cultural resources. See, for example, the letters dated November 12, 2014; March 11, March 27, April 7, September 11, and October 20, 2015; and February 22 and April 5, 2017. Atlantic anticipates meeting with the Nelson County Administration in October 2017 to discuss impacts on historic properties.

See for example, the letters dated January 14, February 2, and September 17, 2015; April 8, June 10, October 22, and December 16, 2016; and March 31 and August 24, 2017. The Nelson County Historical Society additionally provided verbal comments at a DEIS comment meeting in March 2017.

The Rockfish Valley Foundation sent several letters to FERC which were filed to the docket, including letters regarding stakeholder engagement, alternatives, and cultural resources. See, for example, letters dated March 18, March 23, March 26, and September 29, 2015; June 2, September 20, and December 11, December 13, and December 24, 2016; and February 22, February 23, February 28, and April 17, 2017. The Rockfish Valley Foundation additionally provided verbal comments at a DEIS comment meeting in March 2017. Atlantic anticipates meeting with the Rockfish Valley Foundation in October 2017 to discuss impacts on historic properties.

Preservation Virginia sent letters to FERC regarding cultural resources in February 2016 and on June 2, 2016.
