MEETING MINUTES:

The NCSHPO responded to Atlantic's request to discuss concerns expressed in a comment letter from the NCSHPO dated October 11, 2017 on the report titled: *Phase II Investigations, Sites 31NS156, 31RB524, and 31WL374; Atlantic Coast Pipeline Project* (Multicounty, ER 14-1475). A letter response dated October 25, 2017 was prepared by Atlantic to address the concerns expressed by the NCSHPO and provide clarifications regarding a small family cemetery (Taylor Cemetery) that ERM delineated during the Phase II investigations at Site 31WL374.

I (Bill Stanyard) contacted Renee Gledhill-Earley (NCSHPO Environmental Review Coordinator) by email on October 25, 2017 to ask if she would be available to discuss the matter by phone. Renee emailed me the morning of October 26, 2017, and stated that she, Susan Meyers (Assistant State Archaeologist), and John Mintz (State Archaeologist) would be available at 10:30 am, and that they would like me to email a copy of the letter response prepared by Atlantic prior to the call. I emailed the response letter to the NCSHPO, and the call took place at 10:30 am. The participants included Renee, Susan, and John; Richard Gangle (Dominion) also participated.

I reviewed the issues expressed in the October 11, 2017 comment letter from the NCSHPO and provided a summary of Atlantic's responses as provided in the letter dated October 25, 2017. All three representatives from North Carolina acknowledged that the responses were appreciated and satisfactory. However, they stated that ERM did not comply with the entirety of North Carolina's Unmarked Human Burial and Skeletal Remains Protection Act, particularly as it applies to N.C.G.S. § 70-29(c) (1): If the unmarked human burials or human skeletal remains are encountered by a professional archaeologist, as a result of survey or test excavations, the remains may be excavated and other activities may resume after notification, by telephone or registered letter, is provided to the State Archaeologist. The treatment, analysis and disposition of the remains shall come under the provisions of G.S. 70-34 and 70-35.

I acknowledged that I misinterpreted the law to mean if actual <u>human remains</u> were identified. The work ERM conducted at the small cemetery in question exposed only the tops of the grave

shafts as they appeared immediately below the plow zone – therefore, the State Archaeologist was not notified. The work ERM conducted was done in a professional manner and the methods and results were documented in the technical report mentioned above. All three representatives from North Carolina agreed, but requested that, in the future, ERM make the notifications and take the appropriate steps that are stipulated in the law. They also requested that the NCSHPO and Office of State Archaeology be notified even if the information concerning an unmarked human burial or cemetery is anecdotal, so that the information will be in their records should follow-up measures become necessary.

The call ended after I asked if any additional action needed to be taken by ERM or Dominion. The North Carolina representatives stated that no further action is needed, and that they did not have additional questions.
