1.0 RESPONSES TO ENVIRONMENTAL CONDITIONS

1.1 ENVIRONMENTAL CONDITION 6

As required by Environmental Condition 6 of Appendix A to the Order Issuing Certificates (Order) for the Atlantic Coast Pipeline (ACP) and Supply Header Project (SHP) (collectively, the Projects), Atlantic Coast Pipeline, LLC (Atlantic) and Dominion Energy Transmission, Inc. (DETI) are providing the locations and dates of environmental compliance training scheduled to date (Tables 6-1 and 6-2). Atlantic and DETI additionally are providing the names and contact information of the key company personnel responsible for ensuring compliance with the environmental requirements of the Projects in Appendix A (Tables 6-3 and 6-4), which has been filed under separate cover. 1.2 ENVIRONMENTAL CONDITION 41

As required by Environmental Condition 41 of the Order, Atlantic is providing as Appendix B its *Haul Plan* for the ACP. The *Haul Plan* addresses transportation of equipment, materials, and personnel along narrow public roads in steep terrain.

2.0 BIOLOGICAL REPORTS

Atlantic and DETI are conducting surveys for various rare, threatened, and endangered species and/or habitat for these species as recommended by the U.S. Forest Service (USFS), U.S. Fish and Wildlife Service (USFWS), and State/Commonwealth wildlife management agencies. With this filing, Atlantic is providing the following biological survey reports for the Atlantic Coast Pipeline (ACP):

• Habitat Assessments Conducted for Roanoke Logperch (Percina Rex) along the Proposed Atlantic Coast Pipeline in Virginia, Revised; and

• Revised 2017 Freshwater Mussel (Unionidae) Site Assessments and Surveys for the Proposed Atlantic Coast Pipeline in Virginia.

Atlantic sent copies of these reports to the USFWS, USFS, and Virginia Department of Game and Inland Fisheries (VDGIF) for review. Copies of the reports and transmittal letters to the agencies are provided under separate cover as Appendix C. Because the reports contain location information for sensitive species, they are marked "Contains Controlled Unclassified Information and Contains Privileged Information - Do Not Release". Atlantic will file comments from the USFWS, USFS, and VDGIF on each report, when available.

3.0 CULTURAL RESOURCES REPORT

With this filing, Atlantic is providing the following cultural resources report for the ACP:

• Treatment Plan for NRHP Eligible Historic Resource: The Warminster Rural Historic District.
